Active Minds has collected and continues to collect backpacks and personal stories in memory or in honor of loved ones impacted by suicide. By displaying backpacks with personal stories that put a face to lives lost to suicide, Send Silence Packing carries the message that preventing suicide is not just about lowering statistics, but also about saving the lives of students, daughters, sons, brothers, sisters and friends. In 2019-2020, Send Silence Packing was exhibited at 27 college and high school campuses and community spaces, with another 27 planned that had to be cancelled in spring 2020 because of the pandemic.
