As part of our commitment for individuals with autism to reach their fullest potential and in broadening the community of skilled educators, service providers, and family members, we founded the Academy, a training institute in Seal Beach, CA, committed to progressing the field of ABA and ASD by promoting expertise in the application of behavioral approaches.

Our Research Team continues to develop and evaluate cutting edge behavioral approaches that make fundamental differences in the lives of children diagnosed with autism. The teams productivity is difficult to match - averaging 10 peer-reviewed articles a year, totaling 90 publications in 10 years, featured in 24 journals and with the collaboration of over 40 outside researchers.
