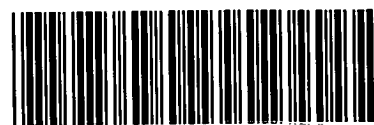

STRATEGIC REPORT

FOR THE YEAR ENDED 31 DECEMBER 2023

The directors present the Strategic Report for the year ended 31 December 2023.

Fair review of the business

ALL.SPACE Networks Limited continued to achieve significant operational and financial milestones during the year.

In March 2023, the business successfully delivered its first terminal to one of our customers for testing over their network. This milestone marks one of the final steps before the company launches its smart terminal to the defence and commercial markets.

The business continued to attract talent in critical areas such as Engineering, Operations, Sales and Marketing and the average number of employees has increased to 182 (2022: 142). Since the year end, further key appointments have been made to strengthen management team that will help the business to achieve its goals in the next 12 months.

We also invested £2.5m in capital expenditure, the majority of which was spent at our Engineering Campus and will enable the business to further develop, build and test our first production terminals.

During the year, the company issued:

- 873,500 Ordinary shares of 0.001p each for cash consideration of £6,106,229 which at the reporting date is unpaid and included in other debtors; and
- 3,801,905 Series C Preferred shares of 0.001p each for cash consideration of £26,825,808 of which at the reporting date £791,512 is unpaid and included in other debtors.

On 29th November 2023, the redemption rights of the preferred shares were removed and the shares were reclassified from financial liabilities to equity at their fair value (note 24).

Principal risks and uncertainties

Whilst we see material demand for the product, we have not yet launched the final product. The key risks are related to supply chain pressures, exchange rate volatility and availability of finance. These risks are monitored by management on a regular basis and mitigated wherever possible.

We have addressed some of the supply chain challenges through forward purchasing of key components utilising venture debt that was secured in the previous year.

The functional currency of the company is pounds sterling, which is also the presentational currency in these group accounts, and the principal currency of the company's cost base. The functional currency of the company's subsidiary undertaking is US Dollars. Future revenues are expected to be denominated in US Dollars. We hedge our foreign exchange exposures via natural hedges.

The proliferation of LEO capacity and the global security and economic challenges give us confidence that the demand for our product is strong and growing. We have an extensive and growing qualified pipeline which sees out forecast first year revenues covered threefold.

As with most deep tech start-ups we remain a capital-intensive business and we will require additional funding to see us through to free positive cashflow. The directors are confident that the required funding will be made available as required.

DIRECTORS' REPORT

FOR THE YEAR ENDED 31 DECEMBER 2023

The directors present their report and consolidated financial statements for the year ended 31 December 2023.

Principal activities

The principal activity of the company and group is the development of an electronically steered antenna with multi-orbit capability together with significant software value added services. The modular design of the antenna will allow us to address the full ecosystem of satellite communications.

Results and dividends

The results for the year are set out on page 9.

No ordinary or preference dividends were paid in the current or prior year.

Qualifying third party indemnity provisions

The company has made qualifying third party indemnity provisions for the benefit of its directors during the year. These provisions remain in force at the reporting date.

Financial risk management objectives and policies

The group's main financial instruments comprise cash and various trading items such as trade debtors and creditors. The group also has non-redeemable preference shares (or "preferred shares"). The main purpose of these instruments is to provide finance for the group's operations.

There are limited risks arising to the group as a result of these instruments and the directors agree policies for the management of these risks, which are summarised below:

Liquidity risk

The group seeks to minimise financial risk by ensuring that appropriate liquidity is available to meet foreseeable requirements. The group's policy is that no trading in financial instruments shall be undertaken until the group meets the objective of funding its own operations.

Foreign currency risk

The group earns a proportion of its income and pays a proportion of its expenses in currencies other than Sterling. The foreign currency used primarily being US Dollars and Euros. Changes in the exchange rate between Sterling and the US Dollar or Sterling and the Euro can expose the group to exchange gains and losses. Local operations in the US create a natural hedge against some of the currency movements and the directors regularly monitor currency balances across the net operating income by currency incurred by the group to manage the foreign currency risk.

Credit risk

The group seeks to minimise any credit risk by dealing only with established or financially sound clients. It also establishes clear contractual relationships and identifies any credit issues in a timely manner. Credit checks are performed on all customers to manage potential exposure for non-payment.

Cash flow risk

To date the group has been loss making as it invests in its research and development activities. The cash position is regularly monitored and the company raised further financing in the year via the Series C equity fund raising.

Research and development

The group has focused heavily on research and development and the group has developed a high-powered computational modelling capability to enable creation of a new kind of microwave refractive beamformer that allows exceptionally tight control over the propagation of radio waves beyond that possible previously. These capabilities leverage new developments in computational modelling, material science, and microwave electronics resulting in a capability that allows the group to produce a specification that satisfies the design constraints for any specific application for satellite communications.

The group's team of industry experts and scientists have achieved innovative antenna design, providing a low-cost solution that can be deployed anywhere in the world quickly, without specialist equipment or training, and in any operational environment. The group's unique satellite communications design incorporates the foundations of a cutting-edge scientific field known as transformation optics, to significantly improve all aspects of bandwidth performance and reduce manufacturing costs, compared to a traditional phased-array and all other variants of flat-panel satellite antennas currently available on the market. The group's antenna system is designed to be used in many transportation systems such as aeronautical, bus and coach, commercial maritime, ferry, rail and defense vehicles. Our US subsidiary is mainly undertaking commercial activities:

Post reporting date events

Since the year end the business has successfully conducted demonstrations for 2 customers ahead of initial production which is expected to commence in the first half of 2024.

Future developments

The principal activity of the company and group continues to be to develop and sell software enabled antennas and related applications for the satellite industry.

Auditor

KPMG LLP were appointed as auditor to the company and in accordance with section 485 of the Companies Act 2006, a resolution proposing that they be re-appointed will be put at a General Meeting.

Going Concern

Notwithstanding consolidated net current assets of £20.5m at the reporting date, a consolidated operating loss for the year of £38.5m and consolidated operating cash outflows for the year of £32.7m, the financial statements have been prepared on a going concern basis which the directors consider to be appropriate for the following reasons.

The group is in the development phase of its lifecycle and is looking to bring products to the market in the future. The financial position of the group, its cash flows and liquidity position and borrowing facilities are described in the primary statements and notes to these financial statements.

As part of their going concern assessment, the Directors have prepared budgets and cash flow forecasts for a period of 12 months ("the going concern assessment period") from the date of these financial statements. These cash flows indicate that additional funding will be required to ensure the group can continue to grow and develop in line with its business plans and meet its liabilities as they fall due during the going concern assessment period.

The group has a history of successfully obtaining the funding necessary to support its plans and should it become necessary the Directors are confident that further funding can be obtained in the future.

Based on the above indications the Directors believe that it remains appropriate to prepare the financial statements on a going concern basis. However, these circumstances indicate the existence of material uncertainty may cast significant doubt on the group's and the Company's ability to continue as a going concern and, therefore, to continue realising its assets and discharging its liabilities in the normal course of business. The financial statements do not include any adjustments that would result from the basis of preparation being inappropriate.

DIRECTORS' RESPONSIBILITIES STATEMENT FOR THE YEAR ENDED 31 DECEMBER 2023

The directors are responsible for preparing the Strategic Report and the Directors' Report and the financial statements in accordance with applicable law and regulations.

Company law requires the directors to prepare financial statements for each financial year. Under that law the directors have elected to prepare the financial statements in accordance with United Kingdom Generally Accepted Accounting Practice (United Kingdom Accounting Standards and applicable law). Under company law the directors must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the group and company, and of the profit or loss of the group for that period. In preparing these financial statements, the directors are required to:

- select suitable accounting policies and then apply them consistently;
- make judgements and accounting estimates that are reasonable and prudent;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the group and company will continue in business.

The directors are responsible for keeping adequate accounting records that are sufficient to show and explain the group's and company's transactions and disclose with reasonable accuracy at any time the financial position of the group and company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the group and company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF ALLSPACE NETWORKS LIMITED

Opinion

We have audited the financial statements of ALLSPACE Networks Limited ("the Company") for the year ended 31 December 2023 which comprise the Consolidated and Parent Company Statement of Financial Position, the Consolidated Statement of Comprehensive Income, the Consolidated and Company Statement of Changes in Equity, the Consolidated Statement of Cash Flows and related notes, including the accounting policies in note 1.

In our opinion the financial statements:

- give a true and fair view of the state of the Group's and of the parent Company's affairs as at 31 December 2023 and of the Group's loss for the year then ended;
- have been properly prepared in accordance with UK accounting standards, including FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland; and
- have been prepared in accordance with the requirements of the Companies Act 2006.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (UK) ("ISAs (UK)") and applicable law. Our responsibilities are described below. We have fulfilled our ethical responsibilities under, and are independent of the Group in accordance with, UK ethical requirements including the FRC Ethical Standard. We believe that the audit evidence we have obtained is a sufficient and appropriate basis for our opinion.

Material uncertainty related to going concern

We draw attention to note 1 to the financial statements which indicates that the group's and parent company's ability to continue as a going concern is dependent on the successful completion of a future funding round. These events and conditions, along with the other matters explained in note 1 constitute a material uncertainty that may cast significant doubt on the group's and the parent company's ability to continue as a going concern. Our opinion is not modified in respect of this matter.

Going concern basis of preparation

The directors have prepared the financial statements on the going concern basis. As stated above, they have concluded that a material uncertainty related to going concern exists. Our conclusions based on this work:

- we consider that the directors' use of the going concern basis of accounting in the preparation of the financial statements is appropriate;

Fraud and breaches of laws and regulations – ability to detect

Identifying and responding to risks of material misstatement due to fraud

To identify risks of material misstatement due to fraud ("fraud risks") we assessed events or conditions that could indicate an incentive or pressure to commit fraud or provide an opportunity to commit fraud. Our risk assessment procedures included:

- Enquiring of directors and inspection of policy documentation as to the Group's high-level policies and procedures to prevent and detect fraud as well as whether they have knowledge of any actual, suspected or alleged fraud.
- Reading Board minutes.
- Using analytical procedures to identify any unusual or unexpected relationships.

We communicated identified fraud risks throughout the audit team and remained alert to any indications of fraud throughout the audit.

As required by auditing standards, we perform procedures to address the risk of management override of controls, in particular the risk that management may be in a position to make inappropriate accounting entries and the risk of bias in accounting estimates and judgements such as provision for loss of contract. On this audit we do not believe there is a fraud risk related to revenue recognition because there are few revenue transactions given the entity is in the early phase of its lifecycle.

We did not identify any additional fraud risks.

INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF ALL SPACE NETWORKS LIMITED (CONTINUED)

We performed procedures including:

- Identifying journal entries to test based on risk criteria and comparing the identified entries to supporting documentation. These included those posted with unusual combination with cash accounts.
- Assessing whether the judgements made in making accounting estimates are indicative of a potential bias.

Identifying and responding to risks of material misstatement related to compliance with laws and regulations

We identified areas of laws and regulations that could reasonably be expected to have a material effect on the financial statements from our general commercial and sector experience, through discussion with the directors and others management (as required by auditing standards), and from inspection of the Group's legal correspondence and discussed with the directors and other management the policies and procedures regarding compliance with laws and regulations.

We communicated identified laws and regulations throughout our team and remained alert to any indications of non-compliance throughout the audit.

The potential effect of these laws and regulations on the financial statements varies considerably.

Firstly, the Group is subject to laws and regulations that directly affect the financial statements including financial reporting legislation (including related companies legislation), distributable profits legislation and taxation legislation and we assessed the extent of compliance with these laws and regulations as part of our procedures on the related financial statement items.

Secondly, the Group is subject to many other laws and regulations where the consequences of non-compliance could have a material effect on amounts or disclosures in the financial statements, for instance through the imposition of fines or litigation. We identified the following areas as those most likely to have such an effect: health and safety, data protection laws, anti-bribery, employment law, regulatory capital and liquidity, and certain aspects of company legislation recognising the nature of the Group's activities.

Auditing standards limit the required audit procedures to identify non-compliance with these laws and regulations to enquiry of the directors and other management and inspection of regulatory and legal correspondence, if any. Therefore if a breach of operational regulations is not disclosed to us or evident from relevant correspondence, an audit will not detect that breach.

Context of the ability of the audit to detect fraud or breaches of law or regulation

Owing to the inherent limitations of an audit, there is an unavoidable risk that we may not have detected some material misstatements in the financial statements, even though we have properly planned and performed our audit in accordance with auditing standards. For example, the further removed non-compliance with laws and regulations is from the events and transactions reflected in the financial statements, the less likely the inherently limited procedures required by auditing standards would identify it.

In addition, as with any audit, there remained a higher risk of non-detection of fraud, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal controls. Our audit procedures are designed to detect material misstatement. We are not responsible for preventing non-compliance or fraud and cannot be expected to detect non-compliance with all laws and regulations.

Strategic report and directors' report

The directors are responsible for the [strategic report and the] directors' report. Our opinion on the financial statements does not cover those reports and we do not express an audit opinion thereon.

Our responsibility is to read the strategic report and the directors' report and, in doing so, consider whether, based on our financial statements audit work, the information therein is materially misstated or inconsistent with the financial statements or our audit knowledge. Based solely on that work:

- we have not identified material misstatements in the strategic report and the directors' report;
- in our opinion the information given in those reports for the financial year is consistent with the financial statements; and
- in our opinion those reports have been prepared in accordance with the Companies Act 2006.

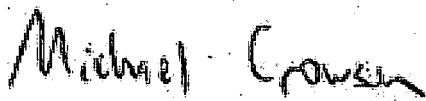
Auditor's responsibilities

1 Accounting policies

Company information

ALL.SPACE Networks Limited ("the company") is a private company limited by shares and is registered and incorporated in England and Wales. The registered office is Unit 1, Now Building, Thames Valley Park Drive, Reading, Berkshire, RG6 1RB.

The group consists of the company and its US subsidiary, ALL.SPACE Networks Inc.

The company's and group's principal activities and nature of its operations are disclosed in the Strategic Report and the Directors' Report.

Accounting convention

These financial statements have been prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102") and the requirements of the Companies Act 2006.

The financial statements are prepared in sterling, which is the functional currency of the company. Monetary amounts in these financial statements are rounded to the nearest £'000s.

The financial statements have been prepared under the historical cost convention, modified to include certain financial instruments at fair value. The principal accounting policies adopted are set out below.

The individual financial statements of the company are included in these consolidated financial statements. The company is a qualifying entity for the purpose of FRS 102, being the parent company of a group that prepares publicly available consolidated financial statements, including the individual financial statements of the company, which are intended to give a true and fair view of the assets, liabilities, financial position and profit or loss of the group. The company has therefore taken advantage of exemptions from the following disclosure requirements for parent company information presented within the consolidated financial statements:

- Section 7 'Statement of Cash Flows': Presentation of a statement of cash flow and related notes and disclosures;
- Section 11 'Basic Financial Instruments' and Section 12 'Other Financial Instrument Issues': Interest income/expense and net gains/losses for financial instruments not measured at fair value; basis of determining fair values; details of collateral, loan defaults or breaches;
- Section 26 'Share based Payment': Share-based payment expense charged to profit or loss, reconciliation of opening and closing number and weighted average exercise price of share options, how the fair value of options granted was measured, measurement and carrying amount of liabilities for cash-settled share-based payments, explanation of modifications to arrangements;
- Section 33 'Related Party Disclosures': Compensation for key management personnel.

Basis of consolidation

The consolidated financial statements incorporate those of the company and all of its subsidiaries (i.e. entities that the group controls through its power to govern the financial and operating policies so as to obtain economic benefits).

All financial statements are made up to 31 December 2023. Where necessary, adjustments are made to the financial statements of subsidiaries to bring the accounting policies used into line with those used by other members of the group.

All intra-group transactions, balances and unrealised gains on transactions between group companies are eliminated on consolidation. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred.

Going concern

Notwithstanding consolidated net current assets of £20.5m at the reporting date, a consolidated operating loss for the year of £38.5m and consolidated operating cash outflows for the year of £32.7m, the financial statements have been prepared on a going concern basis which the directors consider to be appropriate for the following reasons.

The group is in the development phase of its lifecycle and is looking to bring products to the market in the future. The financial position of the group, its cash flows and liquidity position and borrowing facilities are described in the primary statements and notes to these financial statements.

As part of their going concern assessment, the Directors have prepared budgets and cash flow forecasts for a period of 12 months ("the going concern assessment period") from the date of these financial statements. These cash flows indicate that additional funding will be required to ensure the group can continue to grow and develop in line with its business plans and meet its liabilities as they fall due during the going concern assessment period.

The group has a history of successfully obtaining the funding necessary to support its plans and should it become necessary the Directors are confident that further funding can be obtained in the future.

Based on the above indications the Directors believe that it remains appropriate to prepare the financial statements on a going concern basis. However, these circumstances indicate the existence of material uncertainty may cast significant doubt on the group's and the Company's ability to continue as a going concern and, therefore, to continue realising its assets and discharging its liabilities in the normal course of business. The financial statements do not include any adjustments that would result from the basis of preparation being inappropriate.

Turnover

Turnover is recognised at the fair value of the consideration received or receivable for services provided in the normal course of business, and is shown net of VAT and other sales related taxes. The group applies the revenue recognition criteria to separately identifiable components of contracts when necessary to reflect the substance of the transactions. Conversely, the group applies the revenue recognition criteria to two or more transactions in a contract when they are linked in such a way that the commercial effect cannot be understood without reference to the series of transactions as a whole.

Revenue from transactions for the provision of research and development consultancy services is recognised by reference to the stage of completion of the transaction at the end of the reporting period when the stage of completion can be estimated reliably, and when the amount of revenue can be measured reliably and it is probable the economic benefits associated with the transaction will flow to the group. Stage of completion is calculated by comparing costs incurred, mainly in relation to contractual hourly staff rates and materials, as a proportion of total costs. Where the outcome cannot be estimated reliably, revenue is recognised only to the extent of the amount of the expenses recognised that are probable to be recovered.

Research and development expenditure

All research and development expenditure is recognised in profit or loss in the year in which it is incurred.

Intangible fixed assets other than goodwill

Separately purchased intangible assets are recognised at cost and are subsequently measured at cost less accumulated amortisation and accumulated impairment losses.

Amortisation is recognised so as to write off the cost of assets less their residual values over their useful lives on the following basis:

Tangible fixed assets

Tangible fixed assets are initially measured at cost and subsequently measured at cost, net of depreciation and any impairment losses.

Depreciation is recognised so as to write off the cost of assets less their residual values over their useful lives on the following bases:

Leasehold improvements	12.5% straight line
Plant and equipment	12.5% - 33% straight line
Fixtures and fittings	12.5% straight line
IT equipment	33% straight line

The gain or loss arising on the disposal of an asset is determined as the difference between the sale proceeds and the carrying value of the asset, and is credited or charged to profit or loss.

Stocks

Stocks are measured at the lower of cost and selling price less costs to complete and sell. Cost includes all costs of purchase, costs of conversion and other cost incurred in bringing the stock to its present location and condition. Provision is made where necessary for obsolete, slow moving and defective items.

Fixed asset investments

In the separate accounts of the company, interests in subsidiaries are initially measured at cost and subsequently measured at cost less any accumulated impairment losses. The investments are assessed for impairment at each reporting date and any impairment losses or reversals of impairment losses are recognised immediately in profit or loss.

A subsidiary is an entity controlled by the group. Control is the power to govern the financial and operating policies of the entity so as to obtain benefits from its activities.

Financial instruments

The group has elected to apply the provisions of Section 11 'Basic Financial Instruments' and Section 12 'Other Financial Instruments Issues' of FRS 102 to all of its financial instruments.

Financial instruments are recognised when the group becomes party to the contractual provisions of the instrument.

Financial assets and liabilities are offset and the net amounts presented in the financial statements when there is a legally enforceable right to set off the recognised amounts and there is an intention to settle on a net basis or to realise the asset and settle the liability simultaneously.

Basic financial assets

Basic financial assets, which include trade and other debtors, are initially measured at transaction price and are subsequently carried at amortised cost, being transaction price less amounts settled and any impairment losses.

Classification of financial liabilities

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into. An equity instrument is any contract that evidences a residual interest in the assets of the group after deducting all of its liabilities.

Basic financial liabilities

Basic financial liabilities, including trade and other creditors, are initially recognised at transaction price and subsequently carried at amortised cost, being transaction price less amounts settled.

Other financial liabilities

The group had redeemable preferred shares in issue, which also contain an equity conversion option. The equity conversion option fails the fixed for fixed rule in section 22 of FRS 102 because the group may be obliged to deliver a fixed number of its own equity instruments for a variable amount of debt on conversion. As a result redeemable preferred shares were classified and accounted for wholly as financial liabilities with no equity component. The redeemable preferred shares were measured at fair value through profit and loss. The fair value has been measured by using the fair value of the group's equity, based on the latest financing round, and applying it at the reporting date to the equity conversion option in the preferred shares. This approach has been used as a reasonable proxy to what the fair value of the debt component and the equity conversion option would be calculated respectively, by discounting the debt element using a discount factor representative of the weighted, average cost of capital a third party investor would apply for an investment in a company with a risk/return profile such as the company, and calculating the equity conversion option using a valuation methodology which includes (as an input) the fair value of the group's equity, based on the latest financing round.

During the year, the redemption rights of the preferred shares were removed. As the preferred shares can no longer be redeemed and the company is not obliged to declare or pay a dividend in respect of these shares the instruments in issue were reclassified from financial liabilities to equity at their fair value. The fair value has been measured using the fair value of the group's equity, based on the latest financing round. This approach has been used as a reasonable proxy to what the fair value of the instrument would have been had they been issued during the year.

Certain of the preferred shares in issue were issued concurrently with warrants, granting the holder the right to subscribe for ordinary shares in the company for a fixed price. The warrants vested at the point the investor subscribed for the preferred shares. The warrants are accounted for under section 22 of FRS 102, with the consideration received for the preferred shares bifurcated on initial recognition between consideration for the preferred shares, and consideration for the warrants. The initial consideration, and the exercise price, are both denominated in US dollars, and as a result, the obligation to deliver shares fails the fixed for fixed rule in section 22 of FRS 102, resulting in the warrants being accounted for wholly as a financial liability, with no equity component. The warrants are measured at fair value through profit and loss. The fair value has been measured by using the fair value of the group's equity, based on the latest financing round.

Equity instruments

Equity instruments issued by the group are recorded at the fair value of proceeds received, net of transaction costs. Dividends payable on equity instruments are recognised as liabilities once they are no longer at the discretion of the group.

The group has non-redeemable preferred shares in issue which also contain an equity conversion option. As the preferred shares cannot be redeemed and the company is not obliged to declare or pay a dividend in respect of these shares the instruments issued are included in equity at the fair value of the proceeds received, net of transaction costs or at the fair value of the instrument when the redemption rights were removed.

Taxation

The tax expense represents the sum of the current tax expense and deferred tax expense. Current tax assets are recognised when tax paid exceeds the tax payable. Current and deferred tax is charged or credited to profit or loss.

Current tax assets and current tax liabilities and deferred tax assets and deferred tax liabilities are offset, if and only if, there is a legally enforceable right to set off the amounts and the entity intends either to settle on the net basis or to realise the asset and settle the liability simultaneously.

Current tax is based on taxable profit for the year. Current tax assets and liabilities are measured using tax rates that have been enacted or substantively enacted by the reporting date.

Deferred tax is calculated at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled based on tax rates that have been enacted or substantively enacted by the reporting date.

Taxation (continued)

Deferred tax liabilities are recognised in respect of all timing differences that exist at the reporting date. Timing differences are differences between taxable profits and total comprehensive income that arise from the inclusion of income and expenses in tax assessments in different periods from their recognition in the financial statements. Deferred tax assets are recognised only to the extent that it is probable that they will be recovered by the reversal of deferred tax liabilities or other future taxable profits.

Employee benefits

The costs of short-term employee benefits are recognised as an expense as incurred. The cost of any unused holiday entitlement is recognised in the period in which the employee's services are received.

Retirement benefits

For defined contribution schemes the amount charged to profit or loss is the contributions payable in the year. Differences between contributions payable in the year and contributions actually paid are shown as either accruals or prepayments.

Share-based payments

Equity-settled share-based payments are measured at fair value at the date of grant by reference to the fair value of the equity instruments granted using the Black-Scholes-Merton model. The fair value determined at the grant date is recognised on a straight-line basis over the vesting period, based on the estimate of shares that will eventually vest.

In the individual company financial statements, the expense in relation to options over the company's shares granted to employees of a subsidiary is recognised by the company as a capital contribution, and presented as an increase in the company's investment in that subsidiary. The expense in relation to options over the company's shares granted to employees of the company is recognised in profit or loss. A corresponding adjustment is made to equity.

Leases

Rentals payable under operating leases, including any lease incentives received, are charged to profit or loss on a straight line basis over the term of the relevant.

Government grants

Government grants are recognised at the fair value of the asset received or receivable when there is reasonable assurance that the grant conditions will be met and the grants will be received.

Government grants relating to expenditure are recognised as income over the periods when the related costs are incurred. Grants relating to an asset are recognised in income systematically over the asset's expected useful life. If part of such a grant is deferred, it is recognised as deferred income rather than being deducted from the asset's carrying amount.

Research and Development Expenditure Credit

Where research and development expenditure meets the required criteria specified by the local taxation authority to qualify as "qualifying research and development" expenditure and therefore entitles the group to a credit ('RDEC'), then this amount is credited to other operating income in the Statement of Comprehensive Income.

Foreign exchange

Transactions in currencies other than the functional currency (foreign currency) are initially recorded at the exchange rate prevailing on the date of the transaction.

Monetary assets and liabilities denominated in foreign currencies are translated at the rate of exchange ruling at the reporting date. Non-monetary assets and liabilities denominated in foreign currencies are translated at the rate ruling at the date of the transaction and not subsequently re-translated. All such translation differences are taken to profit or loss.

Assets and liabilities of overseas subsidiaries are translated into the group's presentation currency at the rate ruling at the reporting date. Income and expenses of overseas subsidiaries are translated at the average rate for the reporting period, as the directors consider this to be a reasonable approximation to the rate at the date of the transaction. Translation differences are recognised in other comprehensive income and accumulated in equity.

2 Judgements and key sources of estimation uncertainty

In the application of the group's accounting policies, the directors are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.

Key sources of estimation uncertainty

The estimates and assumptions which have a significant risk of causing a material adjustment to the carrying amount of assets and liabilities are as follows:

Stock provision

The nature of the group's business means that stock can become technically obsolete. Assessing the level of provision required for obsolete and slow-moving items of stock is an area of estimation uncertainty which may have an impact on the carrying amount of stock within the next financial year. The stock provision is reviewed by management on a regular basis and amounts are provided for or released as considered necessary. The amounts provided for are generally determined based on factors which include product design changes and future demand which includes assumptions concerning future orders and revenue.

Fair value measurement and reclassification of preferred shares

Redeemable preferred shares were measured at fair value through profit and loss. The fair value at the reporting date has been calculated by applying the market value of the price per share in the company's latest financing round, completed on 5 July 2023 and applying it at the reporting date to the equity conversion option in the preferred shares. This approach has been used as a reasonable proxy to what the fair value of the debt component and the equity conversion option would be calculated respectively, by discounting the debt element using a discount factor representative of the weighted average cost of capital a third party investor would apply for an investment in a company with a risk/return profile such as ALL.SPACE Networks Limited, and calculating the equity conversion option using a valuation methodology which includes (as an input) the fair value of the company's equity, based on the latest financing round.

On 29 November 2023 the redemption rights of the preferred shares were removed. As the preferred shares cannot be redeemed and the company is not obliged to declare or pay a dividend in respect of these shares the instruments in issue were reclassified from financial liabilities to equity at their fair value. The fair value has been calculated based on the latest financing round on 5 July 2023. This approach has been used as a reasonable proxy to what the fair value of the instrument would have been had they been issued during the year.

Accounting and fair value measurement of warrants

In a prior period, the company issued 367,114 Series B1 Preferred shares to an investor for an aggregate subscription price of \$8,000,000. At the same time the company entered into a warrant agreement with the same investor, whereby the investor is entitled to subscribe for up to 95,812 Ordinary shares in the company for a subscription price of \$7.57 per share. The warrant agreement vested at the point the Series B1 Preferred shares were issued, and the options are currently exercisable. The latest date on which the options will lapse is 24 September 2029, but the date on which they lapse depends on various other factors.

The directors have exercised a critical judgement in determining that the warrants were not issued as consideration in a commercial arrangement with the investor and should not therefore be accounted for as a share-based payment arrangement in accordance with Section 26- 'Share-based Payment' of FRS 102 ('Section 26' of FRS 102). Instead, the directors have concluded that the warrants were issued to the investor, in their capacity as an investor, and should be accounted for as such. This is on the basis that there were no other vesting conditions other than the subscription to Series B1 Preferred shares, and no goods or services have been identified as having been received in return for the grant of warrants. As a result, the consideration of \$8,000,000 (£5,775,213 as converted into sterling at the date of the transaction) has been bifurcated between consideration of £4,579,910 for the Series B1 Preferred shares, and consideration of £1,195,303 for the warrants. The consideration has been bifurcated based on the directors' assessment of the relative fair values of the Series B1 Preferred shares and the warrants at the date of initial recognition, as calculated based on the relative number of Series B1 Preferred shares (367,114) and the number of warrants (95,813).

The directors have assessed the warrants against the criteria in Section 22- 'Liabilities and Equity' of FRS 102 ('Section 22' of FRS 102) to determine if the arrangement should be accounted for as debt, or equity. The number of shares the company will issue on conversion is fixed, but the consideration initially received for the warrants, and the subscription price for the ordinary shares under the agreement (\$7.57), are both denominated in US\$. As a result, the consideration for the shares is fixed in US dollars but varies because the functional currency of the company is sterling. The directors have applied common practice under UK GAAP and determined that that the 'fixed-for fixed criterion in section 22 of FRS 102 is not met, and thus that the warrant liability, initially measured at £1,195,303, is accounted for as a financial liability measured at fair value through profit and loss.

The fair value at the reporting date has been measured by using the fair value of the group's equity, based on the latest financing round on 5 July 2023.

Series A, Series A1, Series B1, Series B2, Series B3 Preferred shares and Series C Preferred Shares (the 'preferred shares') confer on the holders the right to receive in priority to the rights of all other shareholders, a fixed non-cumulative preferential dividend ('the preferred dividend'), currently at the rate of \$0.133695 per share for Series A and Series A1 preferred shares, \$0.6552 per share for Series B1, Series B2, and Series B3 Preferred shares and \$0.267 per share for the Series C Preferred shares.

The company is not obliged to declare or pay the preferred dividend in respect of any financial year. No dividend may be declared or paid by the company on the Ordinary shares unless all accruals of the preferred dividend, in respect of that financial year, have been paid to the preferred shareholders pari passu as if they constituted one and the same class. On a liquidation the preferred shareholders have priority for payment of an amount equal to the original subscription price of their shares, plus any arrears or accruals of the preferred dividend.

The preferred shares were redeemable at the option of a majority of the preferred shareholders at any time after 1 January 2025 at an amount equal to the original subscription price of the shares, plus any accruals or arrears of the preferred dividend. On 29th November 2023, the redemption rights of the preferred shares were removed and the shares were reclassified from financial liabilities to equity at their fair value.

The preferred shares are convertible into Ordinary shares at a fixed conversion ratio, defined in the company's articles for each class of preferred shares, at the option of the preferred shareholders.

The Series A2 Preferred shares also convert automatically into an equal number of the same class of shares of the company into which the company's convertible loans convert to, on the same date as the convertible loans convert - refer to note 19 for further details of the convertible loans.
